**ROADS LAW (2005 REVISION)  
SECTION 3 DECLARATION OF INTENT  
SECTION 6 AUTHORITY TO ENTER LANDS**

In exercise of the powers conferred on the Governor in Cabinet by Sections 3 and 6 Roads Law (2005 Revision), acting upon recommendation by the National Roads Authority, it is hereby declared that;

1. It is the intention of the National Roads Authority and in the public interest to open an access road as described hereunder:

**REGISTRATION SECTION:** George Town Central

**REGISTRATION BLOCK:** 13D, 14C

**BOUNDARY PLAN:** BP 574 – Widening of Godfrey Nixon Way

**PORTIONS OF LAND NEEDED:** The proposed roadwork is defined by boundaries outlined in green on BP 574 and listed in the Schedule below.

2. The National roads Authority is authorized to enter upon lands listed in the Schedule below for the purposes of undertaking the road works, such authority to take effect 15 days from the date of publication of this Notice in the Cayman Islands Gazette.

**REGISTRATION SECTION:** George Town  
**REGISTRATION BLOCKS:** 12C  
**BOUNDARY PLAN:** BP 486  
**NATURE OF ROAD WORKS:** Layout of a new public road, as depicted in green on BP 486

1. The National Roads Authority and its agents are authorised to enter upon lands listed in the Schedule below for the purposes of road works as publicly declared as intended under Section 3 The Roads Law (2005 Revision);

Such authority will take effect 15 days from the date of publication of this Notice in the Cayman Islands Gazette;

2.
