## ROADS LAW (2005 REVISION) SECTION 3 DECLARATION OF INTENT

In exercise of the powers conferred on the Governor in Cabinet by Section 3 of the Roads Law (2005 Revision), acting upon recommendation by the National Roads Authority, it is hereby declared that it is the intention of the National Roads Authority to open an access road as described hereunder:

### ROADS LAW (2005 REVISION) SECTION 6 AUTHORISATION TO ENTER LANDS
