### ROADS LAW (2005 REVISION) SECTION 3 DECLARATION OF INTENT

In exercise of the powers conferred on the Governor in Cabinet by Section 3 of the Roads Law (2005 Revision), acting upon recommendation by the National Roads Authority, it is hereby declared that it is the intention of the National Roads Authority to open an access road as described hereunder:

**REGISTRATION SECTION:** Cayman Brac West  
**REGISTRATION BLOCK:** 96E  
**BOUNDARY PLAN:** BP 561  
**PORTIONS OF LAND NEEDED:** The proposed roadwork is defined by boundaries outlined in green on BP 561 and listed in the Schedule below.
