### ROADS LAW (2005 REVISION)

#### Section 5 Declaration

In exercise of the powers conferred on the Governor in Cabinet by Sections 5(1) and 5(2) of the Roads Law (2005 Revision):

The following road is hereby classified as a public road and added to the schedule of public roads:

**REGISTRATION SECTION:** West Bay Beach South

**REGISTRATION BLOCK:** 2D, 12E

Portions of land used for the said road are listed in the Schedule to this Declaration.

**PUBLIC ROAD CLASSIFICATION:** Primary Arterial

**PRESCRIBED COMPOSITE MAP:** PCM 263

**DESCRIPTION:** The public road is defined by boundaries edged in green on Prescribed Composite Map Number 263, which may be inspected at the offices of the National Roads Authority, George Town, Grand Cayman and at the offices of Lands & Survey, George Town, Grand Cayman.
