### ROADS LAW (2005 REVISION) SECTION 3 DECLARATION OF INTENT

In exercise of the powers conferred on the Governor in Cabinet by Section 3 of the Roads Law (2005 Revision), acting upon recommendation by the National Roads Authority, it is hereby declared that it is the intention of the National Roads Authority to open an access road as described hereunder:

**SECTION 5 DECLARATION**

In exercise of the powers conferred on the Governor in Cabinet by Sections 5 of the Roads Law (2005 Revision) the following road is hereby classified as a public road and added to the schedule of public roads:

**ROADS LAW (2005 REVISION)**  
**SECTION 14 DECLARATION**

In exercise of the powers conferred on the Governor in Cabinet by Section 14 of the Roads Law (2005 Revision) acting upon recommendation of the National Roads Authority (NRA), it is hereby declared that the following portion of public road is to be discontinued;

**REGISTRATION SECTION:** SPOTTS  
**REGISTRATION BLOCK:** 24B  
**BOUNDARY PLAN:** BP 545  
**PORTION OF ROAD TO BE DISCONTINUED:** Portion A outlined in red on BP 545.

This portion of road shall cease to be a public road from the day a new portion of public road is constructed to the satisfaction of the NRA as outlined in green on Boundary Plan 546 and upon payment to Crown of CI\$53,768 consideration plus costs by the proprietor of Block 24B Parcel 215.
