## **2. Interpretation**

In these rules "the principal rules" shall mean the Judgment Debts (Rates of Interest) Rules 1995.

## **3. Revision of Prescribed Rates**

- (a) The prescribed rates contained in the principal rules shall be applied for the purposes of calculating pre-judgment and post-judgment interest (in accordance with rules 4 and 5 of the principal rules respectively) for periods up to 31<sup>st</sup> October 2010.
- (b) The prescribed rates contained in the schedule to these rules shall be applied for the purposes of calculating pre-judgment and post-judgment interest (in accordance with rules 4 and 5 of the principal rules respectively) for periods from 1<sup>st</sup> November 2010.
