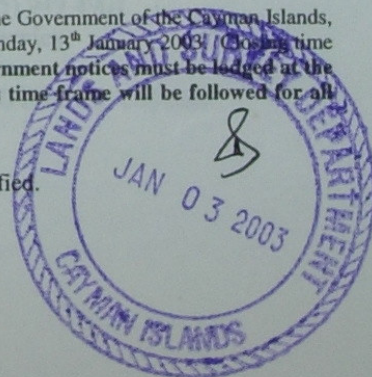

1. It is the intention of Government to undertake the following road works:

**BOUNDARY PLAN:** BP 442  
**NATURE OF ROAD WORKS:**

It is Government's intention to improve parts of Shamrock Road and Hirst Road, as depicted in green on BP 442.
