ROADS LAW (2005 REVISION) Section 5 Declaration of Public Highway

In exercise of the powers conferred on the Governor in Cabinet by Section 5 of the Roads Law (2005 Revision) the following road is hereby classified as a public road and added to the schedule of public roads:

REGISTRATION SECTION: Spotts

REGISTRATION BLOCK: 25B

Portions of land used for the said road are listed in the Schedule to this Declaration.

PUBLIC ROAD CLASSIFICATION: Secondary Arterial

PRESCRIBED COMPOSITE MAP: PCM 290

DESCRIPTION: The public road is defined by boundaries edged in green on Prescribed Composite Map 290, which may be inspected at the offices of the National Roads Authority, North Sound Road George Town, Grand Cayman and at Lands & Survey Dept, 133 Elgin Avenue, George Town, Grand Cayman.
